### 1. About this Cookie Policy

This Cookie Policy explains how Managezy Limited ("we", "us", "OperatEzy") uses cookies and similar technologies on the [www.operatezy.com](http://www.operatezy.com) website, the OperatEzy SaaS admin platform, and the OperatEzy Mobile/Field App. It should be read together with our Privacy Policy.

### 2. What are cookies?

A cookie is a small text file that a website or app stores on your device to remember information about your visit. Similar technologies include local storage, session storage, and tokens used to keep you logged in.

Cookies can be "session" cookies, which are deleted when you close your browser, or "persistent" cookies, which remain on your device for a set period or until you delete them.

### 3. Categories of cookies we use

At launch, OperatEzy uses only strictly necessary cookies and equivalent technologies. We do not use marketing pixels, advertising cookies, analytics cookies, or remarketing cookies. Specifically, we do not use Google Analytics, Meta Pixel, TikTok Pixel, LinkedIn Insight Tag, or any equivalent third-party tracking technology.

### **3.1 Strictly necessary cookies and tokens**

These are required for the Website, SaaS Admin Platform, or Mobile App to function. They cannot be switched off without breaking core functionality. Examples include:

- **Session cookie / authentication token** to keep you safely logged in;
- **CSRF token** to protect against cross-site request forgery;
- **Load balancer or session affinity cookie** set by the hosting infrastructure (Work Mit Uns Kft.);
- **Preference cookies** that remember your language or interface choice during a session.

Because these cookies are strictly necessary to provide the service requested by you, no prior consent is required under Regulation 5(5) of the European Communities (Electronic Communications Networks and Services) (Privacy and Electronic Communications) Regulations 2011 ("ePrivacy Regulations") and equivalent EU/EEA rules.

### **4. No third-party advertising or analytics cookies**

OperatEzy does not currently use advertising, profiling, behavioural targeting, social media plugin, or analytics cookies. If we add any non-essential cookies in the future, we will update this Cookie Policy and ask for your consent through a cookie consent banner before any non-essential cookie is placed on your device.

### **5. How to manage cookies**

You can manage or delete cookies through your browser settings. Most browsers allow you to refuse cookies entirely, accept only certain types, or delete existing cookies.

If you block strictly necessary cookies, parts of the Website, Admin Platform, or Mobile App will not work. For example, you may not be able to log in, stay logged in, or use protected workspace pages.

### **6. Mobile app permissions**

The OperatEzy Mobile/Field App does not use third-party advertising SDKs. App-level permissions (such as notifications, scheduling tools, or location services required for proof of work) are described in the Mobile App Terms of Use and Privacy Policy. You can manage these app permissions at any time through your device settings.
